Fee Discount Policy - AY 2024-25

All discounts offered to students at AGS are solely at the discretion of the Principal and senior management at A'soud Educational Services Company LLC.

Only the Principal is authorized to agree and approve fee discounts at the school; no other colleague within the school, including the school's accountant, may agree or approve fee discounts.

The Principal and senior management at A'soud Educational Services Company LLC retain the exclusive authority to decrease or withdraw discounts from both current and new students at its discretion, with prior notification to parents.

The decisions of both the Principal and senior management at A'soud Educational Services Company LLC regarding discounts are non-negotiable and final.

Students will not be eligible for more than one category of discount in any given academic year.

All discounts for the said academic year for both the old and new students are applicable only with either direct auto debit or 100% advance payment or against PDC's. In case of any delay in payments on the schedule dates, the school reserves the right to withdraw the discount.

The discount policy is applicable for the AY 2024-25 and will be reviewed yearly.

Corporate Discount is applicable to the parents employed with corporate organizations with whom AGS has or will established discount agreement, and which is approved by the senior management.

Ministry Discount is applicable to the parents employed with Ministry with whom AGS has or will establish discount agreement, and which is approved by the senior management.

First Child Discount is applicable in cases where parents have only one child at the school and where that child does not qualify for any other discount type.

Sibling Discount is applicable in cases where an older brother or sister is already on roll and studying in the school and the same parent wishes to enroll his own another child. The sibling discount should be reduced to normal non sibling discount in case the other sibling(s) withdraws from the school
